





a) To pay rents, revenue, cess, rates, assessments and impositions, which may be payable now or in future in respect of Trust properties.

b) To pay all expenses of repairing, maintaining, preserving the trust properties and/or to pay all expenses of construction, reconstruction, renewal, renovation, and improvement of the trust properties or any part/portion thereof as the trustees shall consider fit and proper in their absolute

c) To pay and discharge all costs for establishments, salaries and/or wages of the staff (permanent, temporary, casual and contingent), costs of litigation, if any, in respect of the Trust properties and in the development, improvement, maintenance, management and administration thereof.

4. To raise funds by donation, contribution, fees, maintenance and development charges or from any other sources deemed necessary by the Trustees.

The Trustees shall have the right to operate the Bank accounts as referred in Schedule 'B' and may open Account/Accounts with any other Nationalized or Co-operative Banks, Post Offices and may invest the fund in any such Bank or any other government, Financial Corporation or Company for the development of the property of the Trust.

7. To purchase movable properties including Press, Motorcars, Buses, Machineries, Computers, etc. as may be deemed prudent for the purpose of enhancing income and/or apply the same for implementation of the activities of the Trust.

8. After the fulfillment of the aforesaid activities, the Trustees may undertake the following objects:

a) To establish and run Schools, Colleges, University of high academic attainment and any

b) To establish and run the Technical, Software and Medical Institutions, Veterinary College, Hospitals of all discipline; Institute of Bio Technology, Animal Husbandry apiculture sericulture, Aquaculture etc.

c) To establish and run Hostel, Holiday Home, Old Age Home, Home for destitutes, Adult Education Centre, Literacy Centres, Hospital Medical Care Centre, Charitable Dispensaries etc.;

d) To give donation to other Public and Charitable Institutions and humanitarian organizations and educational institutions;

e) To grant relief at the time of natural calamity and disaster as and when felt necessary and also to grant stipend, scholarships to deserving students, Research scholars and workers for promoting the cause/causes of Literature, Science, Technology, Culture and on the promotion of Human Resource Development;

f) To receive grants, donations from such other National and International Institutions, organisations including State Governments, Central Government and

Just after the registration of this Deed of Trust is completed, the entire amount lying in the Accounts of the Nationalised Bank and in the Fixed Deposit Certificate as given in schedule 'B' hereunder shall be transferred to the said Bank A/c of the 'Vivekananda Education Trust'.

(iv) The Board of Trustees shall hold trustees meetings at least four times a year, preferably, each in every three months. Five Trustees present in the meeting shall form a quorum. The President when present shall preside over all the meetings of the Board

with clear 7 (seven) days notice in writing in consultation with the President. In case of difference of opinion the majority opinion shall prevail. In case of equality of votes, the Trustee presiding over the meeting shall have a casting vote.

(v) In case the Secretary fails to convene the meeting as stipulated herein, the President may convene the meeting of the Board of Trustees. In case of emergency, the President may convene and emergent meeting with 3 days' notice.

(vi) The vacancy in the Board of Trustees when caused, shall be filled up by adoption within six months from the date of vacancy.

(vii) The death, resignation, removal or retirement of any Trustee or Trustees will not affect the management of the Trust, which shall be continued by existing Trustee. No Deed of Conveyance can be created for the property assigned to the Trust.

(viii) The Trustee must be adult.

(ix) The office of the Trustee shall be vacated

 - b) If he becomes insolvent;
 - c) If convicted for offence involving moral turpitude.
 - d) If he dies;
- (x) No individual Trustee shall be liable for any branch of trust committed by any of his co-trustees. No Trustee shall be liable for any loan to the Trust or to the Trust property not attributable to his/her will full commission or omission.
- (xi) All the assets of the Trust shall revert back to the settlers if all the Trustees resign or if a resolution to that effect is passed by the Trustees.
- (xii) The Board of Trustees will otherwise be governed by the provisions of the Indian Trust Act.
